Entry Requirements

1) Visa-exemption

Visitors of the below 81 countries are visa-exempted to enter Macau under “Tourist” status¹.

2) Pre-arrival Entry Visa

Starting from 1 July 2010, visitors from the below 6 countries are required to apply for entry visa in advance through a Chinese embassy or consulate.

- Bangladesh
- Nepal
- Nigeria
- Pakistan
- Sri Lanka
- Vietnam



3) Visa-upon-arrival

Visitors who are not exempted from an entry visa (see list of 81 countries above); nor they are not from the 6 countries that pre-arrival entry visa is required; are required to apply an entry permit (aka “Visa-upon-arrival”) at their arrival to any of the border checkpoints of the Border Control Department of the Public Security Police in Macau.² e.g. at Macau International Airport, ferry terminals and land ports between China PRC and Macau.

The individual Visa-upon-arrival will cost MOP\$200 for a single entry, and \$300 for multiple entry within 30 days.

4) Chinese nationals

Chinese nationals are subject to a “[Permit for Travelling to and from Hong Kong and Macau](#)” (aka “China Exit Permit” 往來港澳通行証) or other travel document issued by the competent entity of the People’s Republic of China.

5) Other visa or entry permit exceptions

Holders of a passport issued by the competent entity of the People’s Republic of China, a Hong Kong Identity Card or an identification document issued to diplomatic and consular personnel by the Hong Kong Special Administrative Region³ are visa-exempted.

Holders of United Nations laissez-passers (UNLP) are visa-exempted.

Special Attention (Proof of Financial Subsistence):

For travelers entering Macau under tourist status, you may be required to provide a proof of financial subsistence. It could be a confirmation of possession of credit cards and/or cash equivalents. This is a verification procedure only instead of paying a fee.

The level of financial subsistence versus length of stay⁴:

Intended length of stay	Possession of Financial Subsistence (value in Macau Patacas MOP)
7 days	At least MOP\$5000
8-14 days	At least MOP\$10,000
15-21 days	At least MOP\$15,000
22 days or longer	At least MOP\$20,000
